We are still finalizing the vendor area layout. Please return the attached form as soon as possible, and we will make every effort to accommodate your needs.

Vendor Guidelines

- A. **Electrical Power** – A limited amount of power may be provided by the hotel. Vendors must arrange any additional needs directly with the hotel. We will try to place you near outlets, but please bring your own extension cords, power strips, and professional-grade tape for securing cords.
- B. **Banners** – Each vendor may display one banner in front of or behind their booth.
- C. **Commission & Fees** – All vendors shall pay the greater of **\$500 or 10% commission** to “California Star Ball” on gross sales, along with a completed tally sheet. These are due no later than **Sunday, November 29th, 2026**.
- D. **Telephone / Internet** – Vendors are responsible for arranging services with the hotel.
- E. **Shipping & Storage** – Vendors must coordinate shipping, storage, and related fees directly with the hotel. Shipping/receiving details will be provided once contracted.
- F. **Setup & Breakdown** – Vendors must be fully set up before the first session and remain until the final session concludes. Load-in/load-out times will be confirmed 30 days prior.
- G. **Insurance** – Upon request, vendors must provide Dance Junkie Productions, Inc. (dba California Star Ball) with a certificate of general liability insurance.
- H. **Compliance** – Vendors are responsible for adhering to all federal and state laws, rules, and regulations governing employment and sales.
